Meeting Format

Minnesota Public Utilities Commission (PUC or Commission) staff will be available throughout the virtual meeting to answer questions about participation in the Commission’s gas resource planning docket. Please come with questions about participation. The question of *which topics* will be included in resources plans is currently before the Commission. Therefore, Staff cannot comment on the merits of potential utility gas resource plan topics (e.g., gas supply procurement, infrastructure, or use of supply- and demand-side resources).

Background

The Commission's February 17, 2023 Order in Docket No. G-999/CI-21-135 found natural gas resource planning to be in the public interest and required three gas utilities to create resource plans. The Order also named the Citizens Utility Board's (CUB) comments on process and content, including CUB's filing made October 14, 2022 in the docket, as the starting point for the establishing content and procedural requirements for gas resource plans. On October 24, 2023 CUB filed an updated gas resource plan proposal in Docket No. G008,G002,G011/CI-23-117. In a Notice of Comment Period issued October 11, 2023 in docket 23-117, parties were asked to use the October 24, 2023 CUB proposal to explain what utilities should be required to include in future gas resource plans.

The Commission intends to hear the matter of Gas Integrated Resource Plans for the first time in February 2024, focused on what should be included in gas resource plans. A second agenda meeting will be held later in 2024 to consider the specific data and models that utilities will use in gas resource plans. Utilities will file their first official gas resource plans sometime after August 2024.
